## **SCHEDULE OF FEES: (Resolution 00-697 & 00-707)**

### Resident Business License Fee:

Businesses with an office or agent permanently located within the boundaries of the City:

Basic fee (covers up to 2 employees):	\$ 50.00
Plus, for each employee in excess of 2:	\$ 5.00

Businesses requiring a heavy industrial zoning classification, irrespective of the actual location of its office:

Basic fee (covers up to 30 employees):	\$300.00
Plus, for each employee in excess of 30:	\$ 5.00

### Non-Resident Business License Fee:

Businesses without an office or agent permanently located within the boundaries of the City:

Annual full year license:	\$100.00
Partial year license (when purchased after July 1 <sup>st</sup> only)	\$ 65.00
Delivery service only:	\$ 40.00

### Temporary License Fee (Per Job):

Issued for a maximum of 20 days. If the job is not completed within 20 days, the regular annual license fee shall be imposed. In no event shall the temporary license fee be applied to an annual business license fee. Temporary license fee shall be equal to 50% of the regular annual license fee.

### Rental Units:

Residential, two or more units (first two):	\$ 50.00
Plus, for each unit over two:	\$ 5.00

Commercial or industrial units (for each unit up to ten):	\$ 25.00
Plus, for each unit over ten:	\$ 15.00

Manufactured Home Park (for each unit up to ten):	\$ 25.00
Plus for each unit over ten:	\$ 15.00
