SCHEDULE OF LICENSE FEES: (Resolution 00-697 & 00-707)

Resident Business License Fee:

Businesses located within the boundaries of the City:

\$50.00 Basic fee (covers up to 2 employees): plus
\$5.00 for each employee in excess of 2

Businesses requiring a heavy industrial zoning classification:

\$300.00 Basic fee (covers up to 30 employees) plus
\$5.00 per employee in excess of 30

Non-Resident Business License Fee:

Businesses located outside the boundaries of the City:

\$100.00 Annual full year license **\$65.00** Partial year license (when purchased after July 1st only) **\$40.00** Delivery service only

Temporary License Fee (Per Job):

Issued for a maximum of 20 days. If the job is not completed within 20 days, the regular annual license fee shall be imposed. In no event shall the temporary license fee be applied to an annual business license fee. \$25

Rental Units:

Residential, two or more units (first two): **\$50.00** Plus, for each unit over two: **\$5.00**
Commercial or industrial units (for each unit up to ten): **\$25.00** Plus, for each unit over ten: **\$15.00**
Manufactured Home Park (for each unit up to ten): **\$25.00** Plus for each unit over ten: **\$15.00**
Short term rental: **\$50.00** per unit.

Business Licenses are required before doing business within the City.
A 10% late penalty for each calendar month or fraction thereof will be added to all delinquent license fees.
